

Anna Legreid Dopp, PharmD, CPHQ

Anna Legreid Dopp is Senior Director, Clinical Guidelines & Quality Improvement at ASHP. In this role she develops therapeutic guidance documents and collaborates with the National Academy of Medicine, National Quality Forum, The Joint Commission, and the Pharmacy Quality Alliance on quality improvement initiatives.

Prior to joining the ASHP staff in 2016, she was Clinical Assistant Professor at the University of Wisconsin School of Pharmacy in Madison and worked in clinical and outcomes research at Medtronic, Inc.

In 2008, she served as a Congressional Health Care Policy Fellow, where she worked on health and social policy in the office of Senator Joe Lieberman. After her fellowship, she served in roles at the University of Wisconsin Hospital and Clinics as a medication use policy analyst and at the Pharmacy Society of Wisconsin as the Vice President of Public Affairs and editor of the Journal of the Pharmacy Society of Wisconsin.

Dr. Legreid Dopp attended North Dakota State University for pre-pharmacy coursework and completed a Doctor of Pharmacy degree in 2002 from the University of Minnesota College of Pharmacy in Minneapolis. She is a certified professional in healthcare quality.



Kimberly Terry PharmD, BCPS, BCCCP

Kimmy graduated from the University of Nebraska Medical Center (2013) and went on to complete a PGY1 (2014) and PGY2 in Critical Care (2015) from Brigham and Women's Hospital in Boston, MA. She had worked for University of Utah Health as a cardiovascular and surgical ICU pharmacist then transitioned to drug information in 2019. Throughout her pre-pharmacy and pharmacy career, Kimmy has been involved with local non-profits that promote equity, bridge communities, and facilitate dialogue around issues such as race and gender.

Carrie Dunford, PharmD, MBA, BCPS
