



enjoys serving in the Utah Society of Health-System Pharmacists and the American Society of Health-System Pharmacists.




### Jeanette Bean, PharmD, BCPS



He received a B.S. degree in pharmacy from the University of Utah and a PharmD degree from the University of Washington. He completed a Clinical Pharmacy Residency at the University of Washington and Harborview Medical Centers, Seattle,

WA, and an Advanced Residency in Primary Care and Family Medicine, University of Washington. Dr. Witt has authored or co-authored over 100 journal articles, 11 book chapters, and given numerous lectures for continuing education programs. His research interests center on providing practical information regarding the optimal use of anticoagulation therapy to front-line practitioners and patients. He was a panel member for the 2012 CHEST Consensus Guidelines for Antithrombotic therapy and as Chair and a panel member for venous thromboembolism guidelines developed by the American Society of Hematology. Dr. Witt also serves on the Medical & Scientific Advisory Board of the National Blood Clot Alliance and is a member of the American College of Clinical Pharmacy, American Society of Health-Systems Pharmacists, and the International Society on Thrombosis and Haemostasis.
