**“Immunization Updates for 2018”**

Objectives (Pharmacists)

1. Differentiate between the two zoster vaccines and two hepatitis vaccines:
  - a. Zoster vaccine recombinant, adjuvanted (ZVR or Shingrix ®) and zoster vaccine live (ZVL or Zostavax ®)
  - b. Hepatitis B vaccine recombinant, adjuvanted (HBVRA or Heplisav-B ®) and hepatitis B vaccine recombinant (HBVR or Engerix-B ®)
2. Choose appropriate patients for administration of the ZVR and HBVRA
3. Schedule appropriate follow up injections for ZVR and HBVRA
4. Assess post-herpetic neuralgia symptoms and design appropriate treatment

Objectives (Technicians)

1. Identify appropriate patients to refer to pharmacist for possible ZVR or HBVRA vaccination
2. Arrange insurance coverage for and/or estimate cost of ZVR and HBVRA
3. Choose appropriate storage of herpes zoster vaccines
4. Select appropriate herpes zoster and hepatitis B vaccine for pharmacist review
